

Terms and Conditions for "Loosable Bonus" Campaign **1. Introduction**These Terms and Conditions ("Terms") apply to the "Loosable Bonus" campaign ("Campaign") offered by **Xellion** ("we", "us", "our") to our clients ("you"). By participating in the Campaign, you agree to be bound by these Terms.

# 2. Eligibility

To be eligible for the Campaign, you must:

- Be a registered client of Xellion with an active trading account on the MT5 platform.
- Make an initial deposit qualifying for the Bonus.
- Accept these Terms during the Campaign period.

## 3. Campaign Period

The Bonus is active for **30 consecutive business days** after activation (i.e., after your initial qualifying deposit).

Xellion reserves the right to extend, shorten, or terminate the Campaign at its sole discretion.

## 4. Bonus Offer

- The Bonus is credited to your MT5 trading account and can be used solely for trading purposes.
- The amount of the Bonus is determined by the Campaign terms at the time of activation.
- The Bonus can be granted only once per client/account.

## 5. Bonus Conditions

- The Bonus cannot be withdrawn and may be lost during trading activity.
- The Bonus will be automatically removed in the following cases:
- At the end of the 30-business-day validity period.
- If the account reaches the Stop Out level.
- Upon any withdrawal request.
- When transferring funds between accounts.
- If the Bonus is misused in any way that threatens Xellion, its systems, or is in violation of the trading rules, including illegal transactions. In such cases, the Bonus may be removed without prior notice.

### 6. Profits and Withdrawals

- Profits generated from trading with the Bonus are withdrawable, subject to Xellion's standard withdrawal rules and procedures.
- Any withdrawal from the account will result in the removal of the Bonus.

# 7. Restrictions

- The Bonus is non-transferable between accounts.
- Each client may participate in the Campaign only once.

#### 8. Amendments and Termination

Xellion reserves the right to change these Terms or terminate the Campaign at any time without prior notice. Any changes will be published on our website. Continued participation in the Campaign after changes are posted constitutes acceptance of the revised Terms.

# 9. Risk Disclaimer and Liability

Trading CFDs involves a high risk of loss and is not suitable for all investors. The Bonus is intended to support trading activity but does not eliminate trading risks. Xellion shall not be liable for losses resulting from market fluctuations or the removal of the Bonus in accordance with these Terms.

These Terms shall be governed by and construed in accordance with the laws of **Saint Lucia**, without regard to its conflict of law provisions.
